The Livingston Parish Council met in a regular session duly called, advertised, and convened at its regular meeting place, at the Governmental Building in the Parish Council Chambers, located on 20355 Government Boulevard, Livingston, Louisiana, on Thursday, November 9, 2023, at the hour of six o'clock (6:00) p.m. with the following Livingston Parish Council members present:

The chair called the meeting to order.

The chair asked the public to please mute or turn off their cell phones.

The chair announced that Public Input would be accepted from any member of the audience wishing to address an agenda item and explained the procedure to be called upon.

The chair addressed agenda item number 7, "Presentations" and advised that there were none that evening.

The chair addressed agenda item number 8, "Notice of Consideration of Action Regarding Sales and Use Tax: Giving notice that Special Taxing District No. 5 will meet on December 14, 2023 to consider taking action regarding the renewal of the levy and collection of an existing sales and use tax dedicated and used to acquire drainage works, equipment, and facilities necessary to construct, maintain and operate outlets for the waters of the district and prevent flooding – Jim Ryan, IRMA, Government Consultants; Parish Legal Advisor and called upon Mr. Ryan.

Mr. Ryan stated that this was just a notice and it needed no motion, no second, no vote then he proceeded to read the notification aloud as follows:

PURSUANT TO LA. R.S. 42:19.1 NOTICE OF CONSIDERATION OF ACTION REGARDING SALES AND USE TAX

NOTICE IS HEREBY GIVEN that the Special Taxing District No. 5 of the Parish of Livingston, Louisiana will meet on Thursday, December 14, 2023, at 6:00 p.m., in the Council Chambers in the Governmental Building, 20355 Government Blvd., Livingston, Louisiana, at which time there will be consideration of action regarding the renewal of the levy and collection of an existing sales and use tax dedicated and used to acquire drainage works, equipment and facilities necessary to construct, maintain and operate outlets for the waters of the District, and prevent flooding.

The chair addressed agenda item number 9, "Adopt a resolution for the Proces Verbal canvassing the returns and declaring the results regarding the Parish's October 14, 2023 election to renew the levy and collection of a 2.5 mill/10 year ad valorem tax for the Parish Health Unit – Jim Ryan, IRMA, Government Consultants; Parish Financial Advisor" and again called on Mr. Ryan.

Mr. Ryan stated that the item was for the Health Unit election just held, and that they'd verbally process the results as it also needed no motion, no second, no vote. He then asked for a resolution

to accept those returns as read and approve the returns of the election. The chair added that he believed that the parish Clerk of Court had done a fantastic job of tallying the vote and making sure that they were accurate.

- SECTION 1. That the Governing Authority does now proceed in open and public session to examine the official certified tabulations of votes cast at the special election held in the Parish on Saturday, October 14, 2023 (the "*Election*"), said tabulations having been prepared and certified by the election officials serving at the designated polling places, and the Governing Authority does now further proceed to examine and canvass the returns and declare the result of the Election.
- SECTION 2. That a Proces Verbal of the canvass of the returns of the Election shall be made and that a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; that another certified copy thereof shall be forwarded to the Clerk of Court and ex-officio Recorder of Mortgages in and for the Parish of Livingston, State of Louisiana, who shall record the same in the Mortgage Records of the Parish of Livingston, State of Louisiana; and that another copy thereof shall be retained in the archives of the Governing Authority.
- SECTION 3. That the result of the Election shall be promulgated by publication in the manner provided by law.
- SECTION 4. In accordance with La. R.S. 18:1292(B)(2) the actual cost of holding the election was [\$9,500.00].
- SECTION 5. This Resolution shall take effect immediately upon adoption.

Said Notice of Special Election was published on Thursday, August 10, 2023, Thursday, August 17, 2023, Thursday, August 24, 2023 and Thursday, August 31, 2023 in the *Livingston Parish News*, as set forth in the proof of publication attached hereto as Exhibit B.

THEREFORE, the Parish Council of the Parish of Livingston, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Livingston, State of Louisiana (the "Parish"), does hereby declare and proclaim in open and public session that the Proposition, as hereinabove set forth, was duly FAILED in the Parish on Saturday, October 14, 2023, and that the results of said election be promulgated by the Secretary of State and by the Clerk of Court in the manner required by law.

She stated that this was not about the homeless and asked where did he come up with that?

Councilman Talbert stated, so because in the last meeting that's what, you're because in the last meeting when you said people were sleeping under the interstate, it was a problem, that's what we were addressing. That was your words at the meeting when Randy asked was this something that was urgent and your words were, we got people sleeping on the interstate, we are addressing homeless people. Councilwoman Sandefur stated that no, Councilman Talbert was addressing homeless people. He said that I just think until we have a solution for homelessness, we don't need to criminalize people having a place to sleep outside. He stated that was his feeling.

Councilwoman Sandefur reiterated that no one was criminalizing that.

The chair called upon Councilman Randy Delatte stated that the ordinance that he read did not have anything to do with homeless people. He stated that it had to do with parking and RVs and tents and camping. He stated that such things happen all over the United States and that laws have to be passed to keep public safe. Councilwoman Sandefur announced that she wished to return back to her item, agenda item 24, "Deer Run settlement agreement discussion – Erin Sandefur", and stated that she felt that she wanted to address the audience to explain why she had placed this item on the agenda. She instructed the audience that she needed the Parish attorney, Mr. Christopher Moody, present to discuss this item.

She wished to address the members of the audience to advise them that she was very mindful and respectful of their time, and the effort that it took for them to be present at the Council meeting that evening. She realized the hardships that it took to make accommodations to attend the Council meetings in person, and she was so sorry that she was going to have to pull her agenda item because the discussion that needed to take place, needed to happen in the presence of Mr. Moody. She once again stated her apologies to them.

The chair stated that agenda item 24 was hereby removed from the agenda.

The chair addressed agenda item number 26, "Adopt a resolution to request an Attorney General's opinion on the Pink Tax exemption – Randy Delatte".

The chair called upon Councilman Randy Delatte who advised that he wished to ask for an Attorney General's opinion on the Livingston Parish Pink Tax exemption. He explained that to do that, a vote of the Council is required for an Attorney General's opinion. He stated that the attorney could also do this, but he preferred it to be done by a vote of the Council. Councilwoman Erin Sandefur stated that she wished to make the second to Councilman Delatte's motion.

Councilwoman Sandefur asked to be allowed to speak when the chair called for discussion.

Councilwoman Sandefur advised that she had received the Parish Council monthly sales and use Road tax report and she asked if they would go back and look at when the pink tax was implemented in September. She advised that by reviewing this report in October, the road tax had suffered. She stated that the Parish did not take in as much as had been received the previous year, because that was what the pink tax had taken from.

Councilman Garry Talbert interrupted her and countered that he bet that Biden-omics took more than the pink tax.

Councilwoman Sandefur stated that she just wished to point that out upon her second to Councilman Randy Delatte's motion.

Councilman Delatte stated that the other thing that he wished to point out that it gave a break not only to the residents of Livingston Parish, but also everyone who lived outside the state or the Parish that shopped through here, or bought gas or passed through here, or did anything else. He wished to state that it wasn't just Livingston Parish residents that received this tax, it was anyone who shopped in the Parish.

Councilman Shane Mack wished for the chairman to clarify what the motion was that they were about to vote upon.

The chair stated that this will ask for a Council resolution asking for the Attorney General's opinion on whether or not the pink tax was legal. He referred to Councilman Randy Delatte for further explanation.

Councilman Delatte stated that they needed as a board to find out if they can legally exempt the pink tax. He stated that the proposition that was voted on by the people was specific on what those exemptions were, and the pink tax was not included in that. He did not want to advise that they could not do it, he thought that it should go back to a vote of the people.

Councilman Shane Mack stated that he agreed with Councilman Delatte's statements.

The chair asked the Council clerk to call for the vote.

The chair clarified that the districts currently zoned would stay so, and those are not, will need to wait until the new administration begins their new terms of office. A brief conversation ensued and the vote was taken.

The chair addressed agenda item number 30a, "Committee Report(s): Finance committee" and advised that they will be meeting on November 30, 2023.

The chair addressed agenda item number 30b, Committee Report(s): Ordinance committee: **Recommendation(s) of Ordinance(s) introduction(s):** Carbon Sequestration Ordinance, Amend Large Lot Subdivision definition" and called upon Councilman Shane Mack, Ordinance committee chairman.

Councilman Mack reported that the committee had met and had a couple of ordinances that they wished to recommend to the Livingston Parish Council to introduce.

He advised that they had discussed introducing an ordinance to enhance the legal descriptions of the reapportionment maps. He advised of the enhancements made by Alvin Fairburn and Associates top better describe boundary locations. He stated that this would be introduced at the next Council meeting on November 30th. The Council district maps are correct, but needed further detailed information to accurately represent the districts.

Councilman Mack discussed the proposed Carbon Sequestration ordinance. It was not ready to be introduced at that evening's Council meeting, however, it will be introduced at the next Council meeting on November 30th and proposed to be adopted on December 14th.

He further continued that there were three (3) ordinances that he wished to present to the Council members that evening. If it was their wishes, they could lift the agenda and introduce these ordinances that evening.

The first ordinance that he wished to present was modifications to large lot subdivisions. This would entail putting a cap on lots that will be allowed to be developed under the large lot subdivision regulations.

He felt that it would be legal for the Council members to vote to lift the agenda for all three (3) proposed ordinance introductions if they so choose.

The second ordinance introduction was zoning classifications and land use modifications. He acknowledged that several months ago the Ordinance committee had met and discussed enhancements to the zoning classifications and land uses, specifically modifications were made to R-1, R-1.5, R-2, and the zoning classification known as "unclassified". He further discussed definitions that were put in place to help with clarifications that were needed.

The third ordinance recommendation was in reference to Class C Road acceptance criteria. He discussed verbiage that had been put in place in the ordinance that has since been deleted. This ordinance introduction would put correct reference to find that information correctly. There is no additions, or modifications to the actual verbiage or the criteria, it is a clerical error that needs to be fixed to find the correct criteria to be referenced correctly.

The chair stated that there had been a motion to lift the agenda to which Councilman Delatte wished to second and those items just discussed could be picked up individually.

Councilman Delatte explained the urgency of this needed ordinance introduction. He stated that there are citizens who have purchased mobile homes and have not been able to move them off of the lots for two (2) months because the zoning classification for R-2 does not include mobile homes.

Public input: DeeDee Delatte, Building and Permit Director requested that the definition of unclassified be included because citizens are not allowed to do anything as well.

There was an open discussion and unclassified definition would not be included.
