#### Minutes of the Livingston Parish Council Livingston, Louisiana February 8, 2024

The Livingston Parish Council met in a regular session duly called, advertised, and convened at its regular meeting place, at the Governmental Building in the Parish Council Chambers, located on 20355 Government Boulevard, Livingston, Louisiana, on Thursday, February 8, 2024, at the hour of six o'clock (6:00) p.m. with the following Livingston Parish Council members present:

The chair called the meeting to order.

The chair asked the public to please mute or turn off their cell phones.

-----

The chair announced that Public Input would be accepted from any member of the audience wishing to address an agenda item and explained the procedure to be called upon.

-----

The chair addressed agenda item number 7a, "Presentations: Recognition of Michelle Temple, Gray's Army Foundation Secretary/Treasurer", and called upon Councilman Billy Taylor.

Councilman Billy Taylor explained that Ms. Michelle Temple founded the Gray's Army Foundation a couple of years ago. Her son went into cardiac arrest at the age of seventeen (17), since then she has had legislation passed to have "AEDs" put into the Livingston Parish School system and has traveled across the country putting "AEDs" in parks and he wished for Ms. Temple to come up to the lectern and explain all the things that she has done.

Ms. Temple introduced herself and her husband, Dale Temple, and advised that they lost their son, Grayson, in December of 2021 at sixteen (16) years of age. He had an unknown underlying arrhythmia. Since then, they have made it their mission to raise awareness for sudden cardiac arrest in youth, especially in student athletes, as sudden cardiac arrest is the number one cause of death in student athletes. Ms. Temple stated that they had just got back from Duke University for a cardiac council meeting and advised that between twenty-two thousand and twenty-three thousand (22,000-23,000) youth have lost their lives in the year of 2022 to sudden cardiac arrest. She advised that part of their mission is to teach CPR, not certified CPR, but hands only CPR, place "AEDs", perform heart screenings, and raise awareness of the signs and symptoms to be looking for in youth. She further advised that they did get legislation passed that requires coaches, trainers and school nurses to take a yearly in-service on recognizing the signs and symptoms of sudden cardiac arrest and how to respond. She explained that they were planning on going back and doing an amendment to that bill that would encourage parents and players to sign a contract, just like the Concussion Act, that would alert them to the signs and symptoms and what to look for and if their child exhibits those symptoms, they will be pulled from play until cleared. Ms. Temple stated that one of their main goals was getting "AEDs" out in the public for public access. She described an event that had taken place at the Live Oak Sports Complex and the need for "AEDs" to be readily available. She advised that they had raised money to donate two (2) "AEDs" to North Park and was working with them for placement. She stated that they would love to see all coaches trained and would like to offer the training to parents and athletes as well. Ms. Temple explained that they do this for free because they want to protect our Parish and protect the citizens to prevent another family from having to experience their loss.

#### LPR NO. 24-058

MOTION was made by Billy Taylor and duly seconded by John Mangus by to adopt a resolution of support to establish the placement of Automated External Defibrillators (AEDs) in recreational parks throughout the Parish of Livingston and encourage all recreational coaches to become certified in cardiopulmonary resuscitation (CPR).

Thereupon the chair declared that the Motion had carried and was adopted on February 8, 2024.

Councilman Ryan Chavers addressed Ms. Temple and advised that he remembered when her son passed and the community involvement and outpouring of love that was given. He stated that needs to carry on with what she was going through. He advised that he was terribly sorry for her loss and he wished to state that she had his full support with what she was doing at these parks and he thought that it was a great idea. He wished to offer whatever he could do to support and help in the Watson-Live Oak area.

Councilman John Mangus wished to offer his help with involvement through his church, the Knights of Columbus and the Men's Club.

The chair addressed agenda item number 7d, "Glen Duncan, Designer, LA State Flag: Presentation of history and remarks on the design of the Official State Flag – John Wascom", and invited Mr. Duncan to come to front from the audience.

Mr. Glen Duncan greeted the Council members and the Parish President and congratulated them on their elected terms of office. He explained his involvement in the design of the Louisiana state flag and the legislation associated with the design. He encouraged the Council members to review the report he had handed out in the form of a booklet which entailed the history of the state flag. Mr. Duncan advised that it was discovered that there were six (6) different state flags being flown throughout the state of Louisiana. He further explained that after contacting the Secretary of State, it was determined that one state flag should be created from scratch to avoid copyright infringement of the different flags being represented. The process of the design took approximately a year and a half, as they looked at all of the law, the culture and all of the history to make sure that it was a natural growth of all of the flags that had come before it. He was extremely proud to be able to tell the Council members about it and he hoped that they enjoyed reading about our state flag. He stated that he was very glad to see that the Council members had the new official flag presented in the Council chambers.

The chair stated that he wished to move agenda item 17 up the agenda to be addressed, to which no one objected.

The chair addressed agenda item number 17, "Adopt resolution to authorize a waiver of Section "125-176, "Definitions" to allow a third address on a two (2) acre tract for Roberta Faye located on 32741 LA Hwy 441 (Parcel #0142190) in Council District 9", and called upon Councilman Joseph "Joe" Erdey.

Councilman Erdey advised that he had viewed the property and spoken to the individuals requesting the waiver. He stated that he, like the rest of the Council members, were not into waivers any longer, but he would like to ask if they would consider it for this particular item. He explained that it was very complicated because of a tornado involved and he had invited the family and Ms. Fay who represented the family, to come and explain why they were requesting the waiver.

Public input: Roberta Oliphant, requesting the waiver

Ms. Roberta Faye Oliphant explained that on December 1, 2023 a tornado came through at ten thirty-five (10:35) p.m. that night and knocked her mobile home over and disconnected her electricity. On December 12<sup>th</sup>, she went to obtain permits to have a camper put in place until she could get something else. She received her permits and on January 29<sup>th</sup> she went back to the Permit office to receive permits for her mobile home and was told by the Permit office that she could not give her a permit because that address had been cancelled. She stated that her nephew had put a mobile home on the back part of the property. She explained that she had received permits in December and now the Permit office advised that they could not give her permits for her new

mobile home. She stated that she has a mobile home that she is "stuck with" and is without a permit to keep her lights on. She advised that she can only have lights for eighteen (18) months.

The chair asked if Councilman Erdey was in favor of granting this waiver.

Councilman Erdey asked Ms. Oliphant if she had her documentation and photos advising that she had this address for almost fifty (50) years. She advised that she did.

Councilman Erdey stated that this was a mix-up and had been family land forever and he felt that this did fall under being a hardship case. He advised that he would like to see the waiver accepted that evening so that her and her family could get back to living normal again.

Councilwoman Erin Sandefur requested if Ms. Oliphant could explain what is currently there on her property for clarification.

Ms. Oliphant advised that a camper is what is currently on the property. She has electricity in her name on the camper. Councilwoman Sandefur clarified that the camper is in place to get Ms. Oliphant through the hardship from the tornado.

Ms. Oliphant advised that she had purchased a mobile home and she is waiting any day for them to come and put it on her property. She stated that she must have her permits in place to give to the mobile home company in order for her new mobile home to be moved onto her property.

Councilman Ricky Goff wished to offer some clarity on Ms. Oliphant's situation.

He explained that there was one (1) piece of property, there was a home on that property and that it had been there for a long period of time.

That home belonged to Ms. Oliphant with a given address.

A tornado came, and took the home away.

Ms. Oliphant obtained a temporary permit for a travel trailer to inhabit until she could get her new mobile home put in place.

He continued to clarify that in the meantime on that one (1) tract of property, her nephew moved in another mobile home.

Ms. Oliphant stated that her nephew had obtained an address in April for that particular mobile home, so at that point and time, there was a home, and a mobile home, located on one (1) tract of property.

Ms. Oliphant needs to obtain a third address on that property for a permanent address.

The chair declared that was what the request for the waiver was for. Councilman Goff concurred and explained that Ms. Oliphant's mobile home has been purchased and is ready to be delivered, but she cannot get power to it. At this time, she is on temporary power for the travel trailer. Ms. Oliphant stated that he was correct.

Councilman Ricky Goff stated that it was his personal opinion that the property should be subdivided and get another address, but it was up to the Council to grant the waiver or not.

He further advised that they could not do this as a hardship because a hardship stipulates a time frame and this is not a time frame. He clarified that there were only two (2) options, deny the waiver and direct Ms. Oliphant to go through the Planning Department and subdivide the property to receive an address, or either grant her a third address on this particular property.

Councilman Erdey advised that he was requesting for the waiver to be granted.

The chair stated that the final inspection of this project was made on February 1, 2022, and all required work, including punch list items, have been completed and the work will be maintained by Livingston Parish.

He questioned if Mr. Browning would like to add any other comment. Mr. Browning advised that the state paid eighty (80%) percent of the construction and the Parish paid the twenty (20%) percent cost share. He added that this was DOTD funding.

Mr. Browning advised that this is a local government assistance program. He indicated that it was a fifty thousand dollar (\$50,000.00) grant request and there was no Parish match.

The chair stated that this would be for constructing an awning for loading and off-loading animals at the Livingston Parish Animal Shelter. Unwanted and stray animals pose a safety and health risk to the approximately one hundred forty thousand (148,000) residents. These improvements serve a vital need within the Parish to improve safety, health and quality of life for our citizens.

Mr. Browning stated that this was a community water enrichment fund for the Town of Springfield to do some improvements that will improve the drinking water in that community. He advised that it was a thirty-five thousand dollars (\$35,000.00) request and there was no Parish match.

The chair addressed agenda item number 11, "Adopt a resolution giving authorization to the Parish President to collect proposals for a professional planner to be used for the fulfillment of zoning in the Parish of Livingston", and called upon Councilman Ricky Goff.

Councilman Ricky Goff advised that he had communicated with the Parish President about this matter. He also knew that the Council had been visiting back and forth with different individuals trying to coordinate.

Councilman Goff stated that the Parish President has agreed to do all of the footwork and bring to the Council his recommendation on someone that could help the Parish so that they could move forward with the Parish's zoning and ordinance clarification. He stated that he would like to make a motion to give that authority to the Parish President.

The Parish President wished to advise the Council members of the possible time frame that it could take for a planning professional to help the Parish with zoning clarifications. He advised of the two (2) planning professionals that they had spoken with, Steven Villavaso and Mr. Jerome. The Parish could sign a contract with Mr. Jerome for eighteen thousand dollars (\$18,000.00) and in sixty (60) days the Parish would be in good shape. Mr. Villavaso could take a year and a half and the costs would be six hundred thousand dollars (\$600,000.00).

Councilman Ricky Goff shared his concerns with choosing Mr. Jerome and had questions about the entity that is behind Mr. Jerome.

Mr. Jerome Fournier introduced himself to the Council members and advised that he was with JPF Consultants, LLC. He stated that he was the Planning Director at Ascension Parish for seven (7) years and retired last June and after his retirement at the beginning of this year, he set up an LLC to do some consulting work. Prior to his tenure with Ascension Parish, he did consulting work and was familiar with the consulting world.

Mr. Fournier advised that it would not be only one (1) person to do all of the work that is consumed here. He stated that he was not an engineer, and when drainage matters come up, they will need engineering assistance. He advised that he will also need assistance with mapping especially as it relates to the zoning ordinance and creating a zoning ordinance for the Parish. He further advised that he does not have a firm that is attached to him at this time in this proposal, but he wished to state to the Council members that the proposal that he submitted to them was a sixty (60) day process and it was eighteen thousand dollars (\$18,000.00). He advised that this would get them a path to move forward with a subsequent contract. He stated that there was a lot of work to be done on the zoning itself, as well as creating a Unified Land Development Code that tells you how you have to develop within those zones.

Mr. Fournier advised that by the time that they get to the end of the moratorium that is in place for twelve (12) months, the work should be done.

The Parish President introduced a gentleman at the lectern who could offer some more clarification. Mr. Max Nassar addressed the Council members and advised that he was the senior vice president of WSP Global. He indicated that they were a seventy thousand (70,000) Global Consulting firm, being a full service consulting firm and work all over the world. They do planning design, consulting design, construction management, project delivery, and just about anything that you could want for any type of infrastructure or planning. He advised that his company had been in Louisiana for about forty (40) years and had permanent offices in New Orleans and Baton Rouge. He encouraged the Council members to look up their website at <a href="wsp.com">wsp.com</a> and informed them that they were on the cutting edge of technologies and global best practices. He stated that they were not under contract to work with Jerome, the work that they were currently doing in support of this planning effort is pro bono for the benefit of the Parish and for the good of the people. Mr. Nassar declared that he had the authority to offer and commit to that, and wished to state that he did, as he was standing there before them.

Councilman Ricky Goff wished to verify that Mr. Nassar would be helping Mr. Jerome with gathering all of the information for direction. He wanted to make sure that everyone understood that this project would costs more than eighteen thousand dollars (\$18,000.00). However, this will get the Parish going in a direction where they could analyze what needed to be done and then move forward swiftly.

The Parish President advised that he wished to call from the audience Mr. Steve Irving who would also be on the team. Mr. Irving will be the legal team member and he is still working under the contract that the previous Parish President had signed.

Mr. Steve Irving addressed the Council members and advised that he was still under contract with the Council. He stated that they will amend that contract and he will finally do what the Council hired him to do last year to clean things up. He advised that what he had discussed with the Parish President was a three (3) part process. The first part is to take the existing zoning ordinance and get it advertised and adopted so that they have a framework to work with. He continued and advised that Phase Two of this will be to take that framework and amend it to be a modern, workable zoning ordinance. Mr. Irving stated that Phase Three would not be sequential and while they were doing Phase One and Phase Two, they would be working on the Parish's development regulations that were in bad need of modification and amendment. He advised that the idea was to follow this three (3) part process and he further advised that the moratorium would not end when Phase One has been completed because Phase One is a structure and it is not intended to be the actual zoning that you will have with the Parish.

Councilman Goff stated that he loved what Mr. Irving was saying, but he wished to know what his title and his credentials were.

Mr. Irving advised that he was a lawyer and had been a lawyer for fifty (50) years. He asserted that he had handled some of the major zoning cases over the years and helped other parishes clean up similar kinds of problems and he was there to help the Parish of Livingston do the same thing.

The chair asked that before they entered into discussions if anyone wished to make a motion to get a direction.

The Parish President stated that his suggestion would cost eighteen thousand dollars (\$18,000.00), and with that suggestion, they really have a path forward. He advised that Mr. Irving had proposed this path last year and they chose not to take it and if they had taken it then, they would not have had some of the legal activities that had occurred. He wished to point out to the Council members that Mr. Irving was the only one that he knew of in the state of Louisiana who has successfully held up against these lawsuits that have been coming. He has continued to beat this, time and time again. He advised that Mr. Irving had to bring his resume to the previous Council members and he even impressed some of their enemies and was hired by a unanimous vote of the Council. The Parish President stated that Mr. Irving's contract was signed, but unfortunately, he wasn't authorized to perform any work. Nonetheless, his contract was still in place with the Parish.

Councilman John Mangus wished to ask Mr. Irving about his predecessor, Councilman Gerald McMorris, and the work he had done diligently to get District 6 zoned and it was never adopted officially. He asked if that information could be used when they build the framework. Mr. Irving stated that as far as he would be concerned, for Phase One, that would be considered property that was zoned. He explained that when he is talking about property that is not zoned, he means the maps that have designated areas that are not zoned. He stated that they would use the existing map of Council District 6, but he couldn't guarantee that parts of that map were not going to be changed and there may be land use issues with that current map.

Mr. Irving explained that Livingston Parish tried to originally adopt a zoning ordinance brick by brick, instead of having one (1) comprehensive ordinance, and that is eventually what caused trouble because there were all kinds of procedural hurdles that needed to be done to adopt a zoning ordinance or amend a zoning ordinance.

She stated that the Council was trying to look deeply into that and understand, and that is part of this, to bring transparency and accountability. Public input: Alderman Mike Fredericks of the Village of Port Vincent

Alderman Fredericks advised that it was a three quarter (3/4) mile long road that was located in between Wall's Seafood and the bar, Whiskey River. He stated that it had become a meeting ground for the Ascension Parish people and the Livingston Parish people late at night and was heavily travelled. He advised that it was a dead end road and those people did not need to be back there. He conveyed that he had spoken to every resident and they are good with that, as well as the land owners. He further advised that it was seventeen (17) residents that included the two (2) property owners, John Doris and Mike Mire. Mr. Fredericks indicated that they were going to do all of the emergency service, mail carriers, everything, they would have a code for the gate to get in and out. He stated that the school bus carries in the front up there by the Hole in the Wall that's been going on since the Flood of '16. He advised that this place used to have sixty (60) renters back there before '16 and it pretty much demolished everything back there, being mainly campers and temporary stuff.

Councilman John Mangus acknowledged that Mayor Angela Elmore of Port Vincent had just entered the Council chambers and wished to call her up to the lectern to speak.

Councilman John Mangus stated that the Village of Port Vincent had a precedent of doing this because of the Cove, which is private.

Councilman Dean Coates stated that they had the reappointments in the audience and asked them to come to the front and introduce themselves to the Council members. He advised that there's a lot of things that the Waterway Commission does and they would like to explain that to everyone.

Public input: Perry Picou, resident of Bear Island, Maurepas, LA and Waterway Commissioner

Mr. Picou advised that he was born and raised and grew up on the rivers. He started the Waterway Commission in 2004 for Livingston Parish. He explained that the Waterway Commission wrote all the criteria for all of the idle zones throughout the Parish. Livingston Parish has more waterways than any other parish in the state of Louisiana, being some six hundred (600) nautical miles. Mr. Picou is the last original board member of the Waterway Commission. There are five (5) members and two (2) alternates on the board. They begin meeting in April and meet at the Killian Town Hall on the first Tuesday of the month at six o'clock (6:00) p.m. Mr. Picou discussed their meeting agendas, the public that sometimes attends their meetings, how they deal with complaints received, they put up flags as well as install signs on a volunteer basis. They usually take three (3) or (4) boat rides a year to place orange flags to help boating traffic see signs along the river. He reported that there were twenty-two (22) deaths in the year 2022. Most were alcohol related boating accidents and drownings. He reported that last year there were seven (7) accidents and no fatalities. Mr. Picou wanted to share some things on their wish list that they have been promised for the last three (3) years that would help the drainage and make the river waterways a lot safer. He shared several places that needed the waterways to be cleaned out. He invited everyone to attend their meetings. He wished to thank Mr. Ronnie Sharp, Mayor of Killian, for letting the Waterway Commission use their facility over the years and his crew, Livingston Parish

Waterway Patrol, "Little Ronnie" Sharp, Louisiana Wildlife and Fisheries and he also wished to thank Eric Edwards with Tourism who has provided funding to help the Waterway Commission.

The chair asked if Councilman Coates wished to reappoint Mr. Perry Picou. He advised that he did, however, he needed to add a few more, Mr. Ernie Balfantz, Kerry McNabb and Mr. Perry Picou. He thanked Mr. Picou for his service with the Waterway Commission.
