# Minutes of the Livingston Parish Council Livingston, Louisiana April 10, 2025

The Livingston Parish Council met in a regular session duly called, advertised, and convened at its regular meeting place, at the Governmental Building in the Parish Council Chambers, located on 20355 Government Boulevard, Livingston, Louisiana, on Thursday, April 10, 2025, at the hour of six o'clock (6:00) p.m. with the following Livingston Parish Council members present:

The chair called the meeting to order.

The chair asked the public to please mute or turn off their cell phones.

The chair announced that Public Input would be accepted from any member of the audience wishing to address an agenda item and explained the procedure to be called upon.

The chair addressed agenda item number 8, "Presentations:", and stated that there would be a presentation of the Golden Heart Award given by the Human Society of Louisiana. He called upon Ms. Stacey Alleman, who operates the inmate/dog housing facility at Dixon Correctional Institute and Ms. Emily Underhill, lobbyist for animal rights.

Ms. Alleman thanked the Parish President and the Council members for allowing them to appear that evening and stated that it was a great honor on behalf of DCI (Dixon Correctional Institute) and the Humane Society to present them with the Golden Heart Award, along with her colleague, Ms. Emily Underhill. She commended the Parish President for making a stand, along with help from the Council members, and bringing this to fruition. She stated that the state of Louisiana has oftentimes been plagued with a horrible and intense animal overpopulation, and they wished to applause each one of them for stepping up to the plate and making this possible. It was her hope that each one of them would accept this recognition and cherish what they have done for the pet population.

Ms. Underhill addressed the Council members and declared that on behalf of the Humane Society, and as a former resident of Livingston Parish, receiving this award was a great step forward for the people of this community and improving the quality of their life by helping to improve the lives of the animals, whether they are pets or strays. She emphasized that they should really be proud of this incredible award. She stated that they were honored to present it to the Parish President Randy Delatte.

The Parish President came to the podium and accepted the Golden Heart Award. The chair allowed time for photo opportunities.

The Parish President wished to declare that he was accepting this award on behalf of the Council and the citizens of Livingston Parish.

He further stated that the Humane Society of Louisiana had reported a concern that involved the Parish fairgrounds giving away live animals, such as rabbits. Upon contact with Councilman Lonnie Watts, who is a member of the Fairgrounds Association, the Association has agreed to ban this practice. In addition, research will be conducted to determine if any further laws or ordinances would be required.

The Parish President invited the Council members for a photo opportunity with Ms. Alleman and Ms. Underhill.

The chair addressed agenda item number 9a, "Parish President's Report: Recognition of Donald Burgess", and advised that Mr. Burgess was unable to attend the meeting that evening and this item was being pulled from the agenda.

The chair addressed agenda item number 9b, "Parish President's Report: Introduction of Ordinance: Declaration of DPW Surplus Equipment", and requested the Council clerk to read the proposed ordinance by title as follows:

MOTION was offered by John Wascom and duly seconded by John Mangus to publish the ordinance by title in the Official Journal in accordance with the legal mandates and set a Public Hearing for Thursday, April 24, 2025 at the hour of six o'clock (6:00) p.m. at the Parish Council Chambers in the Governmental Building located at 20355 Government Boulevard, Livingston, Louisiana, at which time comments will be received on the proposed ordinance prior to a Council vote.

Thereupon the chair declared that the Motion had carried and was adopted on April 10, 2025.

The chair addressed agenda item number 9c:

"Parish President's Report: Introduction of ordinance: Ordinance to declare certain Livingston Office of Homeland Security and Emergency Preparedness movable property available for trade with a current per unit fair market value and allow the proceeds to be reinvested into a new vehicle for uses allowable under HSGP:

i. 2017 Chevy Silverado 4 X 4 crew cab - 3GCUKNEC4HG251459

ii. 2018 Chevy Silverado 4 X 4 crew cab - 3GCUKNEC8JG397093"

The chair advised that Administration no longer desired to include the "2018 Chevy Silverado 4 X 4 crew cab - 3GCUKNEC8JG397093" in the introduction of the ordinance, but did wish to continue with the "2017 Chevy Silverado 4 X 4 crew cab - 3GCUKNEC4HG251459" and called upon the Parish President for further explanation.

The Parish President explained that normally a piece of equipment cannot be traded in because of state law. However, FEMA will be allowing the Parish to upgrade the equipment. In addition, Administration had received a letter from the Parish's legal counsel, as well as the auditor, who believe that because FEMA is giving permission to the Parish to trade in the equipment, the Parish will be allowed to move forward.

The Parish President explained that originally, their request included authorization to trade in two (2) vehicles, having been awarded a grant to upgrade. A quote had been given for both vehicles in the amount of twenty-eight thousand dollars (\$28,000.00), with one (1) not having a transmission. He advised that it was their wish to trade in the vehicle that is without the transmission and now

they desired to keep the 2017 Chevy Silverado 4 X 4 crew cab. He explained that there was a stipulation within the FEMA grant that stated the award has to be given to law enforcement, OEP, and they would be able to satisfy that with the Compliance Department.

The Parish President wished to reiterate that they were requesting to trade in the 2017 Chevy Silverado 4 X 4 crew cab, not the 2018 Chevy Silverado 4 X 4 crew cab.

Councilman John Mangus made the motion to introduce the ordinance and Councilman John Wascom seconded that motion.

The chair called upon the Council clerk to read the ordinance by title as follows:

#### L.P. ORDINANCE NO. 25-06

AN ORDINANCE TO DECLARE CERTAIN LIVINGSTON PARISH OFFICE OF HOMELAND SECURITY AND EMERGENCY PREPAREDNESS MOVABLE PROPERTY AVAILABLE FOR TRADE WITH A CURRENT PER UNIT FAIR MARKET VALUE AND ALLOW THE PROCEEDS TO BE REINVESTED INTO A NEW VEHICLE FOR USES ALLOWABLE UNDER HSGP.

Councilman Dean Coates advised that he thought that they were going to have to make a substitute motion or an amendment to the motion to reduce the truck that President Delatte just spoke of off of the list.

The Parish President agreed and questioned if this could be done by resolution, and not have to be introduced as an ordinance.

Councilman John Wascom advised that he had given this some thought, and did not see why this could not be accomplished by resolution. He explained that this would not be a law, and clarified that the action needed was for the Parish Council to authorize the Parish President to enter into a contract that has already been agreed upon.

The chair asked Councilman Wascom if he wished to make a substitute motion?

Councilman Wascom stated that he would like to make a substitute motion for the Council members to adopt a resolution authorizing Administration to enter into this trade agreement on the 2017 Chevy Silverado 4 X 4 crew cab.

The Parish President advised that as he had spoken earlier, Administration had received letters from FEMA, the auditors and the Parish attorney that indicated that the Parish could trade in the vehicle and it could be done by resolution.

The chair stated that he had a motion by Councilman John Wascom that was duly seconded by Councilman John Mangus.

Councilman Mangus asked Mr. Brad Cascio, Parish legal advisor, if the Council needed to rescind the original motion or was the substitute motion sufficient?

Mr. Cascio advised that if it is a substitute motion, it automatically replaces what had originally been proposed. He stated that the Council would vote on the substitute motion first, and if it passed, the original motion was dead on the floor.

The chair asked if there were anyone present who wished to speak for or against this item? Having none, the chair called for the vote.

as a secondary to provide food for Parish employees during a declared state of emergency during all weather conditions".

The Parish President clarified that when there are emergencies, there are many times that you can rely on volunteers to provide food, but sometimes this is not available because the emergency affects those volunteers. He stated that most times, the Parish is reimbursed by FEMA or whatever the emergency may be. He advised that there were three (3) companies that answered the bid and that it was the wish of Administration to include all three (3) companies using the bid scoring with the highest score being the first primary, the second score to be the secondary and the third placed bid to be third on the list to provide food for Parish employees during a declared state of emergency.

He stated that they hit many, many roads and communities and it was a great event.

The chair addressed agenda item number 15a, "Committee Report(s): Finance Committee", and called upon Councilman Ricky Goff, Finance committee chairman.

Councilman Goff stated that the Finance committee had nothing to report at that time. He advised that they would be scheduling a Finance committee and Infrastructure committee to be held on April 16, 2025.

The chair addressed agenda item number 15c, "Ordinance Committee: Recommendation(s) of Ordinance introduction(s)". The chair advised that the committee had not met, but would be scheduling a meeting for the following Tuesday, on April 15, 2025.

The chair addressed agenda item number 16, "District Attorney's Report" and stated that Mr.

Cascio had to leave the meeting early and was not present.

The chair then moved to the next agenda item, being agenda item number 17, "Councilmembers' Comments".

The chair called upon Councilman John Wascom who wished to recognize Mr. Aswell, reporting for the Livingston Parish News.

Councilman Dean Coates stated that he would like to make an announcement that Administration is working on cleaning out Chinquapin Canal. He advised that this is a really big deal and wanted to applaud the Parish President. He also wanted to applaud what the Parish President had said earlier, trying to get everyone working together again. He thought that really shows his leadership in that area and Councilman Coates was really looking forward to working with the Parish President.

The chair called upon Councilman Joe Erdey. Councilman Erdey advised that last Saturday, April the 5<sup>th</sup>, they held an Albany Hungarian Spring Festival at the Presbyterian Church in Hungarian Settlement. He stated that it was a good time had by all, but the highlight of the event was the appearance of the ambassador from the country of Hungary to the United States. He shared that the ambassador had opened doors for them explaining how their organization could connect with Hungary, granting and aiding them, including awarding scholarships. The ambassador shared that there was a liaison office located in New Orleans who could connect to him very quickly if Mr. Erdey's organization would like to get in touch with him.

Councilman Erdey stated that he was still blown away that an ambassador from another country attended their festival and thanked everyone.

The chair called upon Councilman Ricky Goff who wished to echo Councilman Erdey's statements. He advised that Hungarian Settlement was the largest in the state of Louisiana, and possibly the nation, located in Livingston Parish. He spoke of his time on the Tourism Board and Page | 17

how awesome it was for the ambassador to attend their event. He stated that was just another dedication to the heritage that goes along with the Hungarian Settlement.

He spoke about the Parish President's statements earlier in the meeting and it warmed his heart that this parish was going in really good directions. He applauded the Council as a whole and the Parish President for taking on these challenges and realizing the importance of the Parish.

Upon the conclusion of Councilman Goff's comments, the chair advised that he wished to share a statement for the record.

That statement is as follows, as read by the chairman, Councilman Billy Taylor of Council District 3:

"I'd like to make a statement for the record. At our previous Council meeting on March 28, 2025, Councilman Chavers put into the record that I, the chair, did not put a time limit on the District Rec Administrator and the vice-chair of the Rec Board. Previously, I had explained to the public that Mr. Jim Ryan had called and said that he was ill and was unable to make the meeting. However, there would be board members here to speak on the millage. When the Council members walked into the Council chambers, everyone was presented with two (2) pages explaining the millage and the five (5) year plan. As chair, I considered this as a brief from the park administrator and vice-chair to educate what the millage would be used for as it was done on April 11, 2024 for *Rec District 2. They were provided adequate time to spend and to present their five (5) year plan* to educate the people on the millage after it had failed for the first time. As chairman I will continue to give the presenters adequate time to educate the people where their tax dollars will be spent and give the people the opportunity to speak within the limits of the Council policy on that topic."

The chair stated that he wanted to put that into the record.

Having no further business, a motion to adjourn was requested until they would meet again at the next regular meeting of the Livingston Parish Council scheduled on Thursday, April 24, 2025 at

the hour of six o'clock (6:00) p.m. in Livingston, Louisiana.
