The Livingston Parish Council will add by addendum the following item(s) on the agenda for the May 22, 2025 regular meeting of the Council:

- A-1: Consideration and approval of a project to construct a 30-foot by 60-foot open-air pavilion for public use. The pavilion will serve as a multi-purpose recreational facility featuring picnic tables to accommodate Parish and community gatherings, events, and casual use. The design will also include a secure storage component (15’ x 25’) located under the pavilion to house equipment and items for the Parish Tax assessor’s office use. This project aims to enhance community access to outdoor amenities and improve the functionality of public spaces - Jeff Taylor, Livingston Parish Assessor
- A-2: Adopt a resolution to amend the Livingston Parish Council Policy and Procedure for Public Comment – Billy Taylor
- A-3: Introduction of Ordinance:
Amend Chapter 117, “Zoning”, Division 4, “(R-2) Residential Single Family”, Section 117-155, “Purpose”, Amending Maximum Overall Density of Housing Units and Section 117-157, “Site and Structure Provisions”, Amending Minimum Width Requirements
- A-4: Introduction of Ordinance:
Amend Chapter 117, “Zoning”, Division 3.1, “(R-1.5) Residential – Rural Single Family”, Sections 117-150, to Reactivate the Zoning Classification of “Residential – Rural Single Family (R-1.5)”
- A-5: Introduction of Ordinance:
Amend Chapter 125, “Subdivision Regulations”, Article V, “Subdivisions With Improvements”, Section 125-68, “Procedures for Subdivisions With Improvements”
